1. DATA CONTROLLER AND DATA PROTECTION OFFICER

3. PERSONAL DATA SUBJECT TO PROCESSING

We inform you, in accordance with EU Regulation 2016/679, General Data Protection Regulation, that the personal data provided by you or otherwise acquired by the same in compliance with the legislative provisions in force, may be subject to processing, in compliance with the above-mentioned legislation and confidentiality obligations.

It is understood that Industrial Wear srl may, should they be provided by you and subject to your authorization, process your data relating to your state of health.

4. PURPOSE AND LEGAL BASIS FOR PROCESSING

expectations of the data subject at the time and in the context of the collection of personal data, when the data subject could reasonably expect processing to take place for this purpose.

5. RECIPIENTS OR CATEGORIES OF RECIPIENTS OF THE DATA

The data of a personal nature provided will be communicated to recipients, who will process the data as data controllers (Art. 28 of EU Reg. 2016/679) and/or as natural persons acting under the authority of the Data Controller and the Data Processor (Art. 29 of EU Reg. 2016/679), for the purposes listed above in point 3. Precisely, the data will be communicated to:

- entities that provide services for the management of the information system and communication networks (including e-mail and websites);
- competent authorities for fulfillment of legal obligations and/or provisions of public bodies, upon request.

Subjects belonging to the above categories act as Data Processors, or operate completely independently as separate Data Controllers. The list of Data Processors is constantly updated and available at Industrial Wear srl.

6. TRANSFER OF PERSONAL DATA OUTSIDE THE EU AREA

Personal data are not processed outside the EU Area (EEA).

7. RETENTION PERIOD OR CRITERIA

When we have to collect your personal data, we make sure it is as accurate and up-to-date as possible. If the personal data we collect is no longer needed for any purpose and we are not required by law to retain it, we will make every effort to delete, destroy, or anonymize it.

8. NATURE OF PROVISION AND REFUSAL

The provision of data for the purpose mentioned in point 4. is necessary in order to pursue your legitimate interest i.e. the legitimate expectation of receiving a response to the request for information sent to you. Failure to provide it will result in the impossibility of receiving the desired information.

9. EXERCISE OF RIGHTS

Consistent with the provisions of the RGPD, you have the right to request from the Data Controller, at any time, access to your personal data, the rectification or deletion of the same or to object to their processing; you also have the right to request the restriction of processing in the cases provided for by Article 18 of the RGPD, as well as to obtain in a structured, commonly used and machine-readable format the data concerning you, in the cases provided for by Article 20 of the RGPD.
